
Project Name: Purple Line Bus Rapid Transit Project Client Name: Ramsey County Regional Railroad Authority

The Purple Line is a proposed 15-mile bus rapid transit (BRT) line serving the communities of St. Paul, Maplewood, Vadnais Heights, Gem Lake, White Bear Township and White Bear Lake. The line will connect with existing light rail and BRT service of the METRO system while also creating new stops. There will be direct connections to the Green Line, Gold Line, B Line, G Line and H Line, as well as local and express bus routes. The line will increase accessibility to jobs, housing, and goods and services, thus improving the attractiveness and competitiveness of the east metro area.

Services offered: NEOO leads the real estate market analysis. The analysis will examine the data of all 21 station areas in a post-COVID marketplace and determine where the greatest opportunities are for market intervention for public-private partnerships. NEOO also leads the market research for the housing gap analysis at a micro station area level to further define the tools, strategies and programs required to support the station area planning process. We are running focus group interviews with macro market brokers, developers and the local, community-based organizations to garner feedback on the various station area plans.

In 2021, The City of Rochester retained NEOO Partners to develop the Riverfront Area Small Area Plan in Rochester.
